

Business Jet Direct

The Business Jet Direct Track utilizes the vast resources of FlightSafety International to prepare candidates for careers as professional pilots with corporate flight departments. Each year thousands of aviation professionals are trained by FlightSafety International at nearly 40 Learning Centers in North America and Europe. Business Jet Direct gives FlightSafety Academy graduates the opportunity to join the staff in one of these centers. This networking opportunity puts participants in the right seat of state-of-the-art simulators, allowing them to act as first officers for some of the most well-respected corporate flight departments.

Course Description

Each student must follow the Professional Pilot Program, beginning with Stage 1 (Private, Commercial, Instrument, and Multi-Engine certifications - P/C/I/ME) and will then move on to Stage 2 (Business Jet Direct Track). As in the Professional Pilot Program, you will earn your Single-Engine (S/E) Add-On and Certified Flight Instructor (CFI) rating. Once you successfully complete your CFI, you are eligible to interview with FlightSafety for Business Jet Direct and potential FlightSafety Learning Centers. After a successful interview and being accepted as a FlightSafety First Officer, participants can leave immediately to join a FlightSafety Learning Center or, they can be offered the opportunity to become an Instructor Pilot (IP). They then may instruct at the academy and later proceed to a Learning Center. The more time you spend at the academy, building hours and earning ratings, the easier it will be for you to find employment after Business Jet Direct. Optional ratings include CFI-I (Instructor Instrument) and MEI (Multi-Engine Instructor).

Once you choose to leave the academy, you will begin working at a Learning Center as a First Officer, helping FlightSafety's corporate clients in their initial and recurrent training as well as completing other duties as assigned by the Center Manager.

Hours Requirement

Those who agree to instruct at the academy before entering Business Jet Direct will sign a commitment stating that they will instruct 800 hours of dual-given flight time before leaving the academy. Instructor pay begins at \$16 per hour; instructors are paid for both flying and briefing time. Instructors receive the benefits of a full-time employee including health and dental insurance, 401(k), vacation, sick leave and bookstore discounts. As an academy IP, you will also get the employee rate for CFI-I, MEI and aircraft rentals.

Upon entering Business Jet Direct, participants commit to a Learning Center. The first 4-6 weeks will be spent in Initial Training. Once training is complete, you will spend your time in Academic/Simulator training, operating as a first officer for clients who arrive without a training partner. The pay and benefits can increase with the amount of dual-given hours accumulated at the academy (see chart below).

Benefits

There are three levels at which you can enter Business Jet Direct with varying benefits packages:

Level 1 First Officer Certified Flight Instructor - 450 hours total time**	
Part-time employee \$7 / hour until qualified in the right seat (4-6 weeks), then pay increases to \$7-14 / hour*	
Level 2 First Officer 500 - 1000 hours total time**	
Full-time employee starting at \$14-17 / hour* Opportunity to earn an Aircraft Type Rating	Full benefits including health and dental insurance, 401(k), vacation, sick leave
Level 3 First Officer 1200 - 1500 hours total time**	
Full-time employee Opportunity to earn an Aircraft Type Rating Opportunity to become a Center Simulator / Ground School Instructor	Starting pay range \$17-23 / hour* Full benefits including health and dental insurance, 401(k), vacation, sick leave

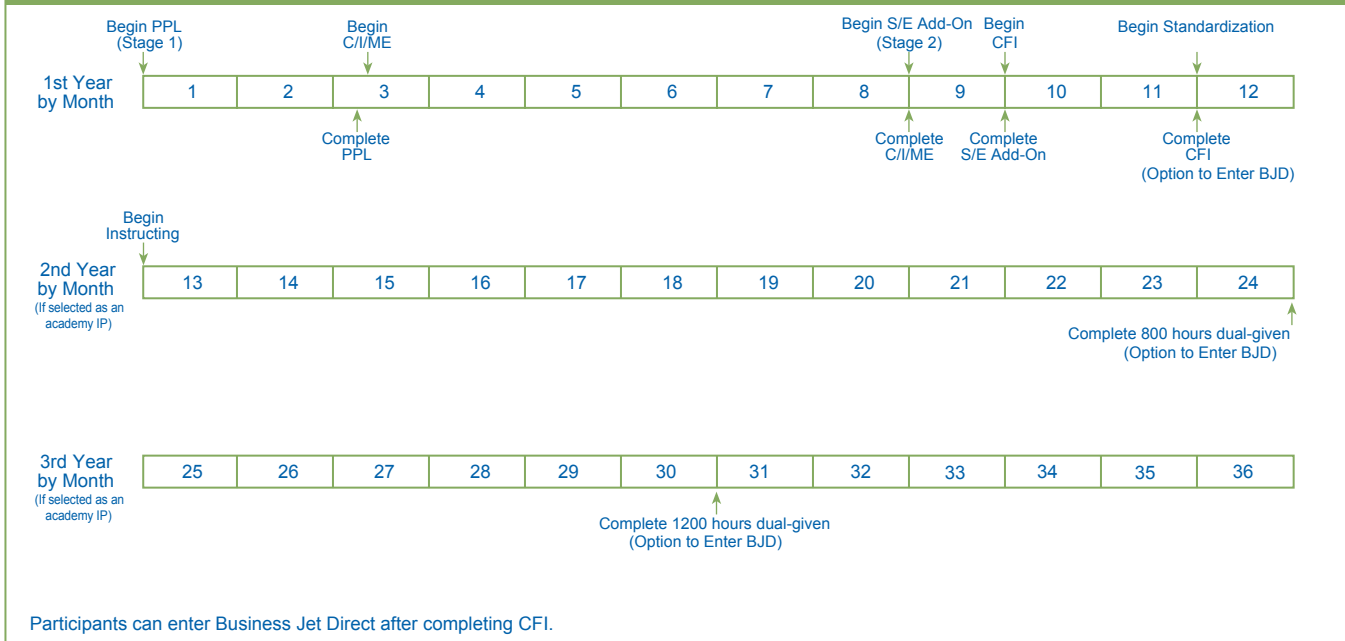
